If you work with the Small Business Development Center (SBDC), we will ask you to provide a signed statement indicating whether SBDC assistance resulted in your company having economic impact in the form of obtaining financing, job creation, business startup or expansion.

If you work with our Procurement Technical Assistance Center (PTAC), we will ask you to provide a signed statement indicating whether PTAC assistance resulted in your company receiving any contract or subcontract award, and we will ask you to provide the specifics of those awards.

We may ask for your written permission to use your name and/or photograph as well as information about your business, for promotional or publicity purposes.

We make every effort to provide prompt, courteous, and professional services within the time frame requested; however, we do not make any warranties or guarantees regarding these services.
